# **Public Works Report - Heather Cail**

### Water & Sewer

Water operations are normal. The master plan proposal from consulting firm EXP is recommended by public works as beneficial for future planning and budgeting for the water system. Waterline on a King Street property was replaced at the owner's expense this past month. An exterior light was vandalized at the water treatment facility. At the Firehall, a new low-flow toilet was installed and other necessary repairs were completed to the waterline. Heather gave a brief report on the annual Wastewater Approval Compliance Evaluation held in the Village with Denis Chenard, Department of Environment on May 29, 2014.

#### Streets & Sidewalks

Streets and sidewalks were swept by equipment owned by Chris Buck. Brown's Paving patched a number of Village side streets; there is a cut on Water Street which needs pavement, and also three more cuts need pavement on Forestdale Road which is a concern as more waterline work needs to be done there. There are two culverts on Water Street which need to be installed and then all culverts in the Village will be done. NB Power representative Bill Gallagher was into the Village Office and spoke with Heather and the Clerk about the major overhaul of transmission lines from Moncton to New Ireland with 213 new poles to be installed beginning the first of June 2014.

#### **Recreation**

The Recreation Centre continues to be significantly used. A roof ridge vent was missing a couple of pieces which was creating leakage inside and this was repaired by siding installer Barry Russell. One new low flow toilet was installed in the ladies washroom.

The Clerk spoke to owners of untagged dogs this past month; three more dogs were tagged for a total of 61 dogs registered to date. A number of owners have not yet come in to the Village Office to tag their dogs.
